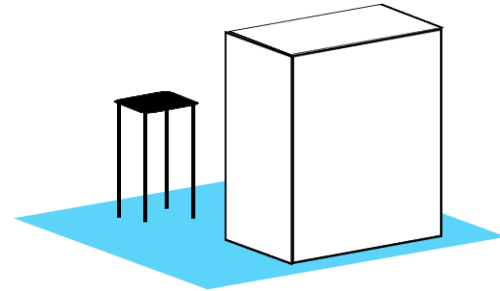
» FORMULA COUNTER SUPPORT - 4 sqm

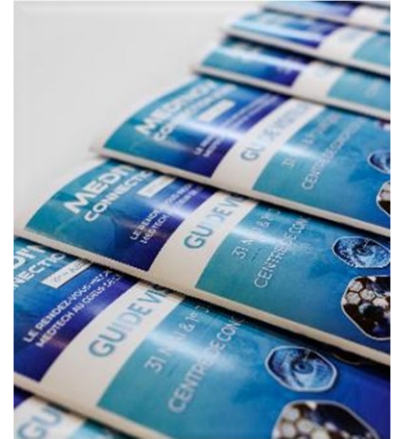

PARTICIPATION CONDITIONS OF MEDI'NOV CONNECTION SPAIN 2024

1. Organization

Medi'Nov Connection Spain 2024 is organized by the company First Connection, a private limited company with capital totalling 20 000 €, whose registered head office is located at 8, rue la Fontaine – 92 120 Montrouge – France, hereinafter the Organizer.

2. Aim

These regulations stipulate the terms and conditions according to which First Connection sets up and runs the Medi'Nov Connection Spain 2024 event. They detail the respective rights and obligations on the part of the participant and Organizer. Organizational arrangements of Medi'Nov Connection Spain 2024 including the dates, duration, location, opening and closing hours are freely determined by the Organizer, who can unilaterally change them. The participant formally undertakes to comply with the present regulations.

3. Location and Dates

Medi'Nov Connection Spain 2024 will take place on June 26 & 27, 2024 at Barcelona (World Trade Center). In the event of impossibility to use the premises planned for cases of force, the Organizer may change the venue or postpone the date if the situation requires so. The Organizer may then cancel the operation after notifying the participant, and in this case, the present application for admission will be automatically cancelled, without any compensation for the participant apart from the refund of the registration fee according to the conditions mentioned in point 4.

4. Case of force majeure

The Organizer may cancel or postpone the Medi'Nov Connection Spain 2024 Exhibition due to force majeure. Cases of force majeure justifying the cancellation or postponement of the exhibition at any time include any new health, climatic, economic, political or social situations on a local, national or international level that were not reasonably foreseeable at the time of communication of the exhibition to the Exhibitors and independent from the Organizer's will, which make the execution of the Contract impossible or which cause risks of disturbances or disorders likely to seriously affect the organization and smooth running of the Medi'Nov Connection Spain 2024 Exhibition, or the safety of goods and persons. In the case of cancellation by the Organizer due to force majeure, the participant undertakes not to exercise any recourse against the Organizer after payment of the expenses incurred. The available balance will be distributed among the Exhibitors in proportion to the payments made. In the event of postponement by the Organizer due to force majeure, the Organizer will inform the Exhibitors of the new organizational arrangements as soon as possible.

5. Admission, Registration, Payment, Cancellation

Any company or institution is entitled to participate if it has the relevant skills in the medical field. The Organizer reserves the right to refuse any application, whatever the reason, and without having to justify its decision. In the event of a participant withdrawing before Wednesday May 22, 2024, the signatory is liable for 50% of the initial participation fee, to cover the organizer's costs. Withdrawal from the event can only be notified to the Organizer by registered letter with acknowledgement of receipt. After that date, registration for Medi'Nov Connection Spain 2024 is definitive and irrevocable, and the participant is liable for the complete amount of his participation. The total amount of the participation fees is due at the latest 3 weeks before the event so on Wednesday June 5, 2024.

6. Services included in the price of participation

The fixed price of participation fee is € 1 500 with the option of selecting additional access passes and options (indicated on the registration form). This registration fee for Medi'Nov Connection Spain 2024 includes the services described in the dedicated sections of the registration form.

7. Commercial rules

The Participant may not allow any other company to benefit from the services offered by Medi'Nov Connection Spain 2024 without the prior consent of the Organizer. The participants formally undertake not to perform activities outside the confines of the meeting center premises similar to those offered within, and this for the whole duration of the event.

8. Non-obligation clause

The Organizer undertakes to diligently use the resources available to it, without being subject to an obligation of result.

9. Use of the event on-line platform

The Participant undertakes to be responsible for any technical requirements needed to enable him/her to access the Medi'Nov Connection Spain 2024 website, app or other platform made available by the Organizer to facilitate his participation to the Event. The Organizer does not guarantee that the Medi'Nov Connection Spain 2024 platform will operate continuously, securely or without errors or interruption, and does not accept any liability for its temporary unavailability. The Organizer does not guarantee that the Medi'Nov Connection Spain 2024 platform will be free from viruses, infections, worms and/or any other code that has contaminating or destructive properties. The Participant undertakes not to interfere with the proper working of the Medi'Nov Connection Spain 2024 platform and agrees to comply with any website terms of use and/or fair or acceptable use policies indicated on the website on which the Medi'Nov Connection Spain 2024 platform is hosted.

10. Privacy and security policy

The Participant understands that the Organizer will collect detailed information about its business for the sole purpose of conducting the Event and delivering the services described in the registration validation. More information is available on the website of the Organizer.

11. Insurances

As the Organizer of Medi'Nov Connection Spain 2024, First Connection is legally responsible for the event. This civil responsibility in no case covers damages caused by a third party to the participants. The World Trade Center engages its civil responsibility as owner of the building and installations, permanent or temporary, used for the Exhibition. The participant is responsible for all damages caused to others by him/herself, his/her staff or his/her installation. The participant must be covered by a civil responsibility insurance, and insure the equipment belonging to him/her or which comes into his/her possession during the meeting.

12. Application of regulations

The Organizer reserves the right to decide on all cases not covered in these regulations, and to introduce any necessary amendments or additional clauses to this matter, which shall come immediately into force. The circulars sent to participants later are an integral part of these regulations. Any infringement of these regulations may lead to the expulsion of the participant committing the infringement, on the sole decision of the Organizer First Connection, without official notification and without refund due for the participation fee or any sum paid to it, which will be retained by the Organizer.

13. Powers

By signing the registration form, the participant declares that they have unconditionally accepted the clauses of these regulations. In case of a dispute and before any proceedings, the participant undertakes to submit its complaint to the Organizer. In the event of a dispute, the courts assigned to the registered offices of First Connection will entertain sole jurisdiction.
