STRASBOURG EVENTS cannot be held liable in any way for the loss or destruction of any equipment left behind after the event.

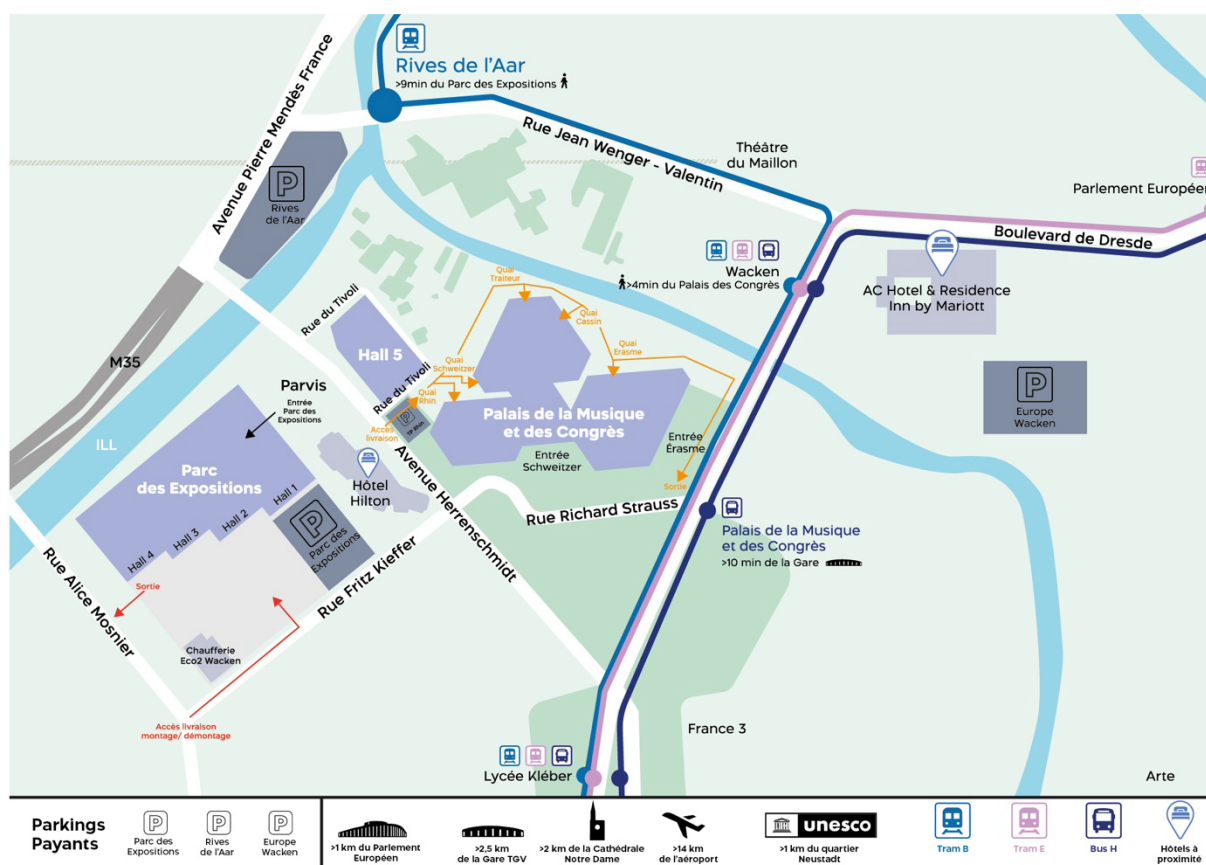
A3P assumes no liability for the loss, theft, or damage of packages during transport. It is your company's responsibility to purchase, if necessary, insurance covering the shipped equipment.

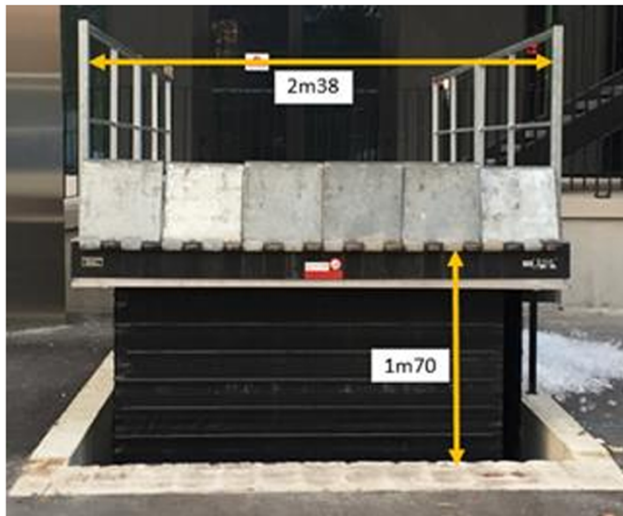
